To outsource the preparation of your income tax return to an accountant in India, it is necessary to provide your name, address and social security or tax identification number along with your tax information to the accountant half-way around the globe over a seemingly secured, encrypted upload/download link. New IRS regulations now require that you acknowledge that your return information is traveling this electronic pathway. You need to be aware of this outsourcing to India to get your accountant-prepared return done for about 40% of the price local accountants in the Northern Nevada area are charging.

Consent to Disclosure of Tax Return Information

(Per the IRS this statement must not be altered in any fashion)

Federal Law requires this consent form be provided to you. Unless authorized by law, we cannot disclose, without your consent, your tax return information to third parties for purposes other than the preparation and filing of your tax return and, in certain limited circumstances, for purposes involving tax return preparation. If you consent to the disclosure of your tax return information, Federal Law may not protect your tax return information from further use or distribution.

You are not required to complete this form. Because our ability to disclose your tax return information to another tax return preparer affects the service that we provide to you and its cost, we may decline to provide you with service or change the terms of service that we provide to you if you do not sign this form. If you agree to the disclosure of your tax return information, your consent is valid for the amount of time that you specify. If you do not specify the duration of your consent, your consent is valid for one year.

The consent to disclose may result in your tax returns information being disclosed to a tax return preparer located outside the United States, including your personally identifiable information such as your Social Security Number (SSN). Both the tax return preparer in the United States that will disclose your SSN and the tax return preparer located outside the United States which will receive your SSN maintain an adequate data protection safeguard (as required by the regulations under 26 U.S.C. Section 7216) to protect privacy and prevent unauthorized access to tax return information. If you consent to the disclosure of your tax return information, Federal agencies may not be able to enforce U.S. laws that protect the privacy of your tax return information against a tax return preparer located outside the U.S. to which the information is disclosed.

If you agree to allow our firm to disclose your tax return information, including your SSN for purposes of providing assistance in the preparation of your income tax returns, beginning with
